MAHARASHTRA BOXING ASSOCIATION

Election Process - 2022

1. Electoral College List:

- A. Each District / City Boxing Association shall be represented by two members authorized by the President or Secretary General/Secretary of the duly affiliated District / City Boxing Association however, in case President / Secretary General / Secretary nominates different person(s), the person (s) authorized by the President shall be deemed to be the duly authorized person(s).
- B. Each duly provisional affiliated Unit shall be represented by one representative and shall not have voting right.
- C. Each District / City Boxing Association and each provisional affiliated Unit shall intimate the name(s) of their representative(s) latest by 4th June, 2022 and such intimation shall be addressed to the President / Secretary General of Maharashtra Boxing Association on their letter head duly signed by President / Secretary of that District / City Boxing Association, so as to reach him on or before the 4th June, 2022, the format of such letter is annexed hereto as "**Annexure A**".
- D. Any change in the name of any authorized representative after 4th June, 2022 or any intimation received thereafter shall not be permitted.
- E. The President / Secretary General of Maharashtra Boxing Association shall prepare the list of the authorized representatives of the District / City Boxing Associations ("Electoral College List") in the prescribed "**Form 1**" annexed hereto as "**Annexure B**" and circulate a copy of the list so prepared by him to all District / City Boxing Associations latest by 5th June, 2022, by display on the website of Maharashtra Boxing Association. This list shall be treated as the Final list of Voters.

2. Nomination of Candidates:

- A. The nomination of a candidate for election as President or Secretary General or Treasurer or Vice President or Executive Secretary or Administrative Secretary or or Divisional Secretary shall be made in prescribed "**Form 2**" annexed hereto as "**Annexure C**".
- B. The nomination of a candidate for election as President or Secretary General or Treasurer or Vice President or Executive Secretary or Administrative Secretary or or Divisional Secretary shall be proposed by one of the authorized representatives of the District / City Boxing Associations whose name is included in the Electoral College List in "Form 1" and also subscribed by 1(one) such authorized representative as seconder.
- C. Each candidate shall be entitled to be nominated by not more than 2 (two) nomination papers.
- D. Each nomination paper shall be delivered by email to the Returning Officer by the candidate himself / herself from 6th June, 2022 to 8th June, 2022 up to 06.00 pm only.
- E. No person shall be eligible to nominate more than one candidate for the same post, either as proposer or seconder; Please note that if he so does, his/her signature on the nomination papers delivered second in point of time to the Returning Officer shall be deemed to be inoperative
- F. No person shall be permitted to withdraw his / her name as proposer / seconder, once the nomination paper subscribed by him / her has been delivered to Returning Officer.
- G. On 10th June, 2022, the Returning Officer shall prepare a list of all nominations received by him; post wise in prescribed **Form 3** annexed hereto as "**Annexure D**"; and the list of nominations received will also be displayed on web site of Maharashtra Boxing Association.

3. Scrutiny of Nominations:

- A. On 11th June, 2022 at 11.00 am to 01.00 pm, the Returning Officer in his office shall scrutinize each nomination paper, one by one, received by him and determine its validity or otherwise.
- B. At the scrutiny of nominations, each candidate or one of his / her authorized representative shall have the right to be present and raise any objection in relation to nomination of a candidate for the post of which he / she has filed his / her nomination.

- C. As soon as may be after the scrutiny of all nomination papers has been completed by him, the Returning Officer shall prepare a list of validly nominated candidates in prescribed "Form 4" annexed hereto as "Annexure E" and circulate copy of the list so prepared by him to all District / City Boxing Association by display on the website of Maharashtra Boxing Association. The contesting candidates can take a copy of a list of validly nominated candidates from the Returning Officer.

4. **Withdrawal of Candidatures:**

- A. Each candidate whose nomination has been found valid on scrutiny shall be entitled to withdraw his / her candidature from 11th June, 2022 to up to 05.00 P.M. of 13th June, 2022.
- B. Notice of withdrawal of candidature shall be submitted in prescribed "Form 5" annexed hereto as "Annexure F", either by the candidate himself / herself or by a person duly authorized by him / her in writing.
- C. Notice of withdrawal of candidature shall be final and shall not be allowed to be cancelled.
- D. The Returning Officer shall accept the notice of withdrawal if he is satisfied as to the genuineness of the notice.
- E. On the 14th June, 2022, the Returning Officer shall prepare final list of contesting candidates in prescribed "Form 6" annexed hereto as "Annexure G", and display copy of the said list on website of Maharashtra Boxing Association and also furnish a copy of the same to each of the candidates / their authorized representatives if they so demand.

5. **Poll:**

- A. The poll if necessary shall be taken post-wise, on 19th June, 2022 and shall commence at during the Annual General Meeting called for the elections.
- B. The poll will be by secret ballot.
- C. Each contesting candidate can nominate one person, (if he / she so desires), to be present at the Poll (Polling Station).
- D. The voter shall record his / her vote on the ballot paper by placing a tick mark (\checkmark) against the name of the candidate of his / her choice, and any other mark like (X) etc. or word , placed on the ballot paper by him / her shall render the ballot paper liable to rejection.
- E. The tick mark (\checkmark) to indicate the vote shall be placed by the voter only by means of article specifically provided for the purpose by the Returning Officer, and a ballot paper marked otherwise by means of any pen, ball point pen etc. by the voter shall render the ballot paper liable to rejection.
- F. The ballot paper marked by a voter shall be deposited by him / her in a ballot box specially prepared and sealed by the Returning Officer and placed at such a conspicuous place in the polling station that it shall be constantly visible to all present in the polling station.
- G. The ballot papers for the post of President or Secretary General or Treasurer or Vice President or Executive Secretary or Administrative Secretary or Divisional Secretary are annexed hereto as "Annexure H" to "Annexure N".
- H. The Returning Officer shall close the poll at the appointed hour; however, all those voters who are present at the polling station at the appointed closing hour shall be entitled to vote even if the poll proceedings have to be continued for some more time.
- I. After all the voters have voted, the Returning Officer shall close the ballot box and shall not permit thereafter any person to vote.

6. **Counting of Votes:**

- A. The Returning Officer shall take up the counting of votes, post –wise and category wise.
- B. The Returning Officer shall thereafter ascertain the result of counting, the candidates who have secured maximum no. votes in the said descending order, post- wise and category wise, where applicable, equal to no. of seats to be filled for each post or category of posts, where applicable, shall be deemed to have been duly elected to those posts.

7. **Declaration of Results:**

The names of contesting candidates who have been elected at the election shall be declared as having been duly elected to their respective posts, by the Returning Officer at the General Meeting or at such other meeting or time as deemed appropriate in prescribed "**Form 28**" annexed hereto as "**Annexure O**".

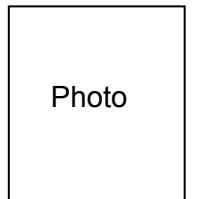

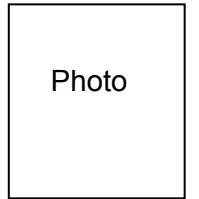

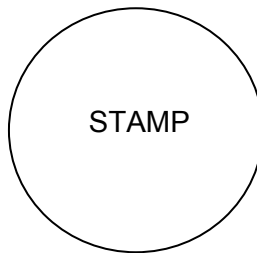
